#### Notification

S.O.--- Whereas the Central Government, after considering the report submitted to it, is satisfied that the model described in the said report (see the figure given below) is in conformity with the provisions of the Legal Metrology Act, 2009 (1 of 2010) and the Legal Metrology (Approval of Models) Rules, 2011 and the said model is likely to maintain its accuracy over periods of sustained use and to render accurate service under varied conditions;

Now, therefore, in exercise of the powers conferred by the second proviso to section 22 of the Legal Metrology Act, 2009 (1 of 2010) read with sub-rule (6) of rule 8 and sub-rule (4) of rule 11 of the Legal Metrology (Approval of Models) Rules, 2011, the Central Government hereby approves, issues & publishes the certificate of approval of model of CNG Dispenser with Mass Flow Meter (hereinafter referred to as said model) of make "Micromotion" manufactured by M/s Tulsa Gas Technologies India Pvt Ltd, 517, HSIIDC Industrial Area, Kundli-131028, District Sonapat, Haryana and which is assigned the approval mark IND/09/12/401;

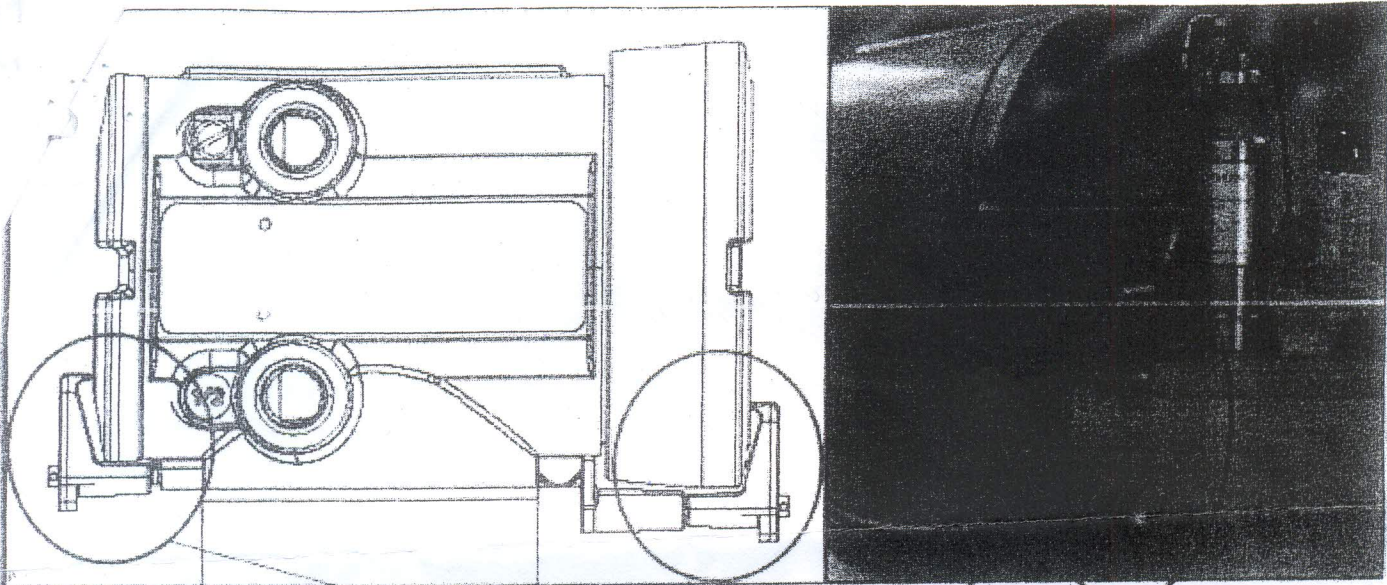
The said CNG Dispenser with mass flow meter which calculates the weight of the gas through sensor and transmits it to the electronic register having integral display and the dispensed quantity is displayed on the electronic display. The flow rate range is 0 to 100kg/min and size is 12.7mm (1/2").
